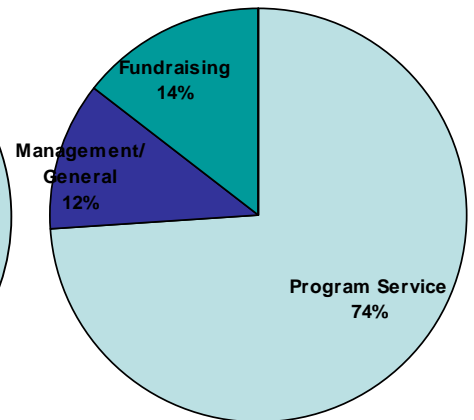
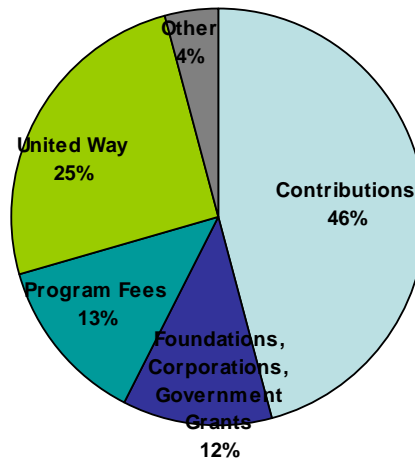
What makes Sherwood Forest Camp unique?

In 2007, Sherwood Forest Camp celebrated 70 years of helping underserved children discover and develop their full potential. Sherwood Forest is the only residential camp in the region dedicated to working with underserved children beginning at age 7 and culminating with graduation from our nationally recognized Leadership Training Program at age 16.

In 2007 we served 367 children (unduplicated) in Summer Camp, and 888 students in Outdoor Education. Without the support and hard work of more than 900 donors and 250 volunteers none of this would have been possible. We thank you!

Summer Camp

Summer camp costs just over \$170 per day per child. With over 80% of our children coming from families who live at or below the federal poverty level, an experience like this would not be possible without generous community support. Most families can only afford to pay the \$25 deposit. Your gifts provide the additional funds needed for these children to attend camp. Campers participate in creative and performing arts, team building and sports activities, reading, outdoor living skills, and aquatic activities throughout the summer. These experiences give children opportunities to master essential life skills: trust, creativity, communication, leadership, mutual support, safe risk-taking, and conflict resolution.
